## **Half-Cent Sales Surtax Extension**

In November 2020 ballot, Odyssey parents will have an opportunity to vote on a proposal for the "Half-Cent Sales Surtax Extension for Critical School Facility, Security, and Technology Upgrades." The purpose of the sales surtax extension is to upgrade aging schools in Brevard County with critical school facility renewal projects, including school security and technology modernizations. Odyssey Schools are not permitted to promote the ballot, but we would like to share with you ways this money would be used if the ballot were to pass.

For the first time in Brevard's history, because the laws of Florida have changed, public charter schools will now benefit from the sales surtax based upon their proportionate share of the district's enrollment. This surcharge will be for 6 years and if passed is expected to bring in approximately \$6,000,000 in total or \$1,000,000 per year into Odyssey schools.

A facility needs assessment is being conducted in the near future, but it is anticipated that if received these funds would be spent upon needed Facility, Educational Technology, Security, and Bus Transportation projects. Some of these needs would include upgrades for our HVAC system, interior and exterior painting, sports field bleachers, roofing upgrades, buses to reduce over-crowding, computers and technology infrastructure, redesign and upgrading of playground equipment, and school lighting and security enhancements. ### **Classroom Neutrality**

I am pleased to announce that the Odyssey Charter School Board has approved a new "Classroom Neutrality" policy for our schools. We have a deep respect for first amendment rights – freedom of speech – and the rights of parents.

#### **Classroom Neutrality**

Neutrality in both curriculum and classroom instruction is paramount to creating an atmosphere of inclusiveness, where all students, regardless of their beliefs and opinions, feel welcome.

A Staff member's personal opinions on social or political issues (even on ones of great public importance) are not necessarily representative of Odyssey as an institution, and should not affect the performance of their duties.

#### **Our Obligations to Students:**

•Shall not unreasonably deny a student access to diverse points of view.

•Shall not intentionally suppress or distort subject matter relevant to a student's academic program.

·Shall not intentionally expose a student to unnecessary embarrassment or disparagement.

-Shall not harass or discriminate against any student on the basis of race, color, religion, sex, age, national or ethnic origin, political beliefs, marital status, handicapping condition, sexual orientation, or social and family background and shall make reasonable effort to assure that each student is protected from harassment or discrimination. Obligations to the Public:

•Shall take reasonable precautions to distinguish between personal views and those of any educational institution or organization with which the individual is affiliated.

·Shall not intentionally distort or misrepresent facts concerning an educational matter in direct or indirect public expression.

·Shall not use institutional privileges for personal gain or advantage.

## **Curriculum Notes on Core Knowledge History**

Along with Studies Weekly, Odyssey utilizes Core Knowledge History for grades K-6th. Core Knowledge History offers a comprehensive program, rich in content, that focuses upon world civilization, American history, and geography—integrating topics in both civics and the arts. This helps students build knowledge (or cultural literacy). Cultural literacy is the basic knowledge needed for communicating and functioning in contemporary society leading to a high level of literacy. Parents wanting to view Core Knowledge History can do so from the Canvas site.

An important note to parents from Core Knowledge History: Since religion is a shaping force in the story of civilization, the Core Knowledge Sequence introduces children in the early grades to major world religions, beginning with a focus on geography and major symbols and figures. The purpose is not to explore matters of theology but to provide a basic vocabulary for understanding many events and ideas in history. The goal is to familiarize, not proselytize; to be descriptive, not prescriptive. The tone should be one of respect and balance; no religion should be disparaged by implying that it is a thing of the past. To the question, "Which one is true?," an appropriate response is, "People of different faiths believe different things to be true. The best people to guide you on religious beliefs are your parents."

#### **New Growth**

This year brings new growth to our schools. Our new Wellness and Performing Arts Centre has opened and is beautiful. As soon as COVID-19 calms down, we would love to have our students give you a tour. Although the Centre will primarily be used on a daily basis by the Jr/Sr High, there will be ample opportunity for both Odyssey Elementary and Odyssey Preparatory to use the gymnasium for celebrations, graduation, and other events. There is a beautiful outdoor sitting area for upper classmen, and the new track and soccer field are well underway with plans for it to be completed by mid to late October. The organic farm has been relocated and will be ready for planting by mid-October as well.

On the Eldron campus, work was delayed due to planning and zoning issues surrounding the buffer on our property. Although this took much longer than what we anticipated, construction is fully back on track and we are anticipating the completion of our extended car loop by some time in November, which will add 45 additional parking spaces. Our teachers' parking lot, adding 75 additional parking spaces, and new soccer field and track are slated to be completed by mid-December and our classroom addition, by mid to late January. A new playground space is also being planned for installation next summer. These much needed additions will bring over three additional acres to our campus, a new classroom wing, a total of 115 new parking spaces, and create a much safer car loop, moving traffic off of Eldron and providing two separate drop-off zones for our students. We look forward to these improvements and ask for patience during this school year until work is completed.
